Council moves to next phase of downtown library

The City Council is moving ahead with the next important phase of the downtown library project after endorsing the final schematic designs for the facility.

While enthusiastically approving the designs prepared by Group 4 Architects, the Council on Nov. 21 also directed the firm to prepare construction drawings for the 42,000-square-foot library and the underground parking garage that will be built on the site of the current library.

The City is planning to break ground on the \$27 million library and \$16.5 million parking garage in April 2008 and open the library in spring 2010.

"It's exciting to see the concepts evolve into a real design that gives the new library an attractive identity," said Assistant City Manager Lorie Tinfow, project manager.

Watch City Council meetings online

Walnut Creek will begin offering live streaming video of its City Council meetings on the Internet in January.

On Jan. 16, online access to the live broadcast of the City Council meetings will be available for the first time on the City's website, walnut-creek.org.

All meetings will be shown live online, and within 24 hours thereafter will be available online for future viewing. Further, all Council meetings dating back to Aug. 1, 2006 will be available in an archive that can be viewed online.

The agenda of the meeting will be posted alongside the video screen, and a user may click on a particular agenda item

and watch it instantly in streaming video.

The new service, provided by Granicus of San Francisco, will work with PCs and Macintosh computers, although best viewing of the video is available on broadband Internet browsers.

"This is the first step — we are going to be continually enhancing this feature," said City Clerk Patrice Olds. "I am thrilled to make this service available. It will provide improved efficiency and meet the City's mission to provide better and more convenient access to government decision making."

In the coming months, the City also plans to link documents and staff reports

Free tax prep help for low income earners

Limited to moderate-income residents and seniors can get free tax preparation assistance Feb. 5 - April 16 from AARP Tax-Aide, which will again be providing services at two locations in Civic Park: Park Place, 1395 Civic Dr., Monday-Wednesday, 9 a.m.-3 p.m. (call 925-335-8749 for an appointment); and Civic Park Community Center, 1375 Civic Dr., Thursdays only, 9 a.m.-2 p.m. (call 925-943-5851). Appointments may be made starting Jan. 2. In 2006, 1,027 residents were assisted in Walnut Creek; over 11,000 total were assisted throughout Contra Costa County. This service is made possible with a grant from the IRS and private donations.

Recycle your old batteries in WC

In February 2006 it became illegal to throw any type of batteries into commercial and residential garbage or recycling containers. All batteries must, by law, be properly recycled. The Central Contra Costa Solid Waste Authority has arranged with local retailers to provide battery recycling. Those merchants in Walnut Creek who now accept single-use household batteries are: Long's Drugs stores at 1123 S. California Blvd., 1914 Tice Valley Blvd., 738 Bancroft Ave., and 2222 Oak Grove Rd., and Rite Aid Drugs at 1526 Palos Verde Mall. Dog park underway; Mt. Diablo Blvd. repaving work done

Work has begun on a new, permanent dog park at the north end of Heather Farm Park.

The one-acre dog park is expected to be opened by summer. The park will be fully accessible and include fenced off lawn areas separating small/senior dogs from larger dogs, new sycamore and flowering pear trees, and benches to be donated by WCDOG.

In other news, the City completed downtown repaving work on Mt. Diablo and California boulevards and Alpine Road in October. The City installed new landscaping on the median on Olympic Boulevard at the I-680 onramp.

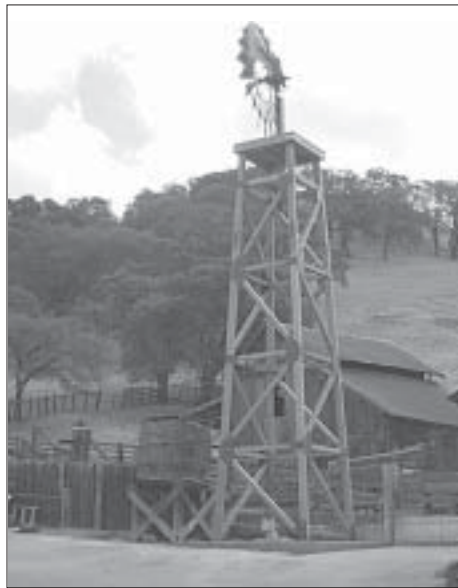
Downtown kiosks installed

Get ready for next emergency with CERT training offered by City, County fire district

Get ready to help yourself and your community in 2007 – sign up for Community Emergency Response Team (CERT) training.

The six-week course includes lessons on suppressing small fires, shutting off utilities, light search and rescue, disaster psychology, disaster First Aid, triage, and many other response techniques.

Upon graduation, people will be assigned to a CERT Area. If a disaster strikes, CERT team members are encouraged to check on their own families and home first, and then assemble at a pre-designated site to work together to respond to the needs of the neighborhood.

Safety is the most important goal of CERT teams, and no one is asked to put him or herself in danger. In fact, the CERT motto is to “do the greatest good for the greatest number while protecting yourself from becoming a victim.”

More than 325 people in Walnut Creek have taken the training since its inception in 2004.

CERT is a partnership of Walnut Creek’s Citizen Corps Council and the Contra Costa Fire Protection District.

CERT will be offered four times in 2007. The first series of classes will be held Tuesday evenings, Feb. 6 – March 13. Other six-week sessions begin April 18, July 24 and Sept. 19. All classes take place from 6 – 9:30 p.m. at the Fire District Training Center, 2945 Treat Boulevard, Concord.

City helps maintain low flood insurance for WC residents

For the second straight year, residents will continue to enjoy a 15 percent discount on their flood insurance premium rates thanks to another high rating for Walnut Creek based on a 2006 FEMA audit of its community floodplain management activities.

Based on the City’s activities to reduce the frequency and severity of flooding events in certain affected areas, Walnut Creek received a rating of 7 from the National Flood Insurance Program, which translates to a 15% discount in the flood insurance premiums (an average savings of \$800) paid by local homeowners.

Walnut Creek is one of 1,049 communities nationwide receiving the discounts based on its efforts to reduce flood losses, ensure accurate insurance ratings, and promote awareness of flood insurance that go well beyond the National Flood Insurance Program’s minimum requirements.

A Look Back: History of WC's electric railway

Twenty years after the first steam trains chugged into Walnut Creek, the first electric rail service was inaugurated to provide new transportation links through Alameda and Contra Costa counties.

On Dec. 31, 1910, just weeks after electrical service was introduced to businesses on Main Street, the first train on the Oakland, Antioch & Eastern (OA&E) Railway rolled into Walnut Creek. The depot was located at the site of what is today the Leshar Center for the Arts at the southeast corner of North California Boulevard and Civic Drive.

The electric railway initially connected Walnut Creek with Concord and Bay Point, and soon thereafter with Lafayette, Orinda, Oakland, and San Francisco. An eight-mile Danville branch line left the Saranap station (where Olympic Boulevard and Tice Valley Boulevard meet today) — named for Sara Naphtaly, wife of the vice president of the railway, Samuel Naphtaly. In 1928, the service was renamed Sacramento Northern.

Among its virtues, the railway provided clean, reliable transportation for Walnut Creek students to Mt. Diablo High School in Concord for nearly 30 years.

However, the popularity of automobiles and bus service, along with the opening of the San Francisco-Oakland

Bay Bridge and Caldecott Tunnel in the mid-1930s, spelled the end of passenger service in 1941. A commemorative

passenger run occurred in 1964 prior to the tracks being removed and the creation of California Boulevard in 1967.

Historic preservation ordinance up for planning review

A draft historic preservation ordinance crafted by the Walnut Creek Historical Society, local business owners, and residents last fall is scheduled to be reviewed by the City's Planning Commission in January.

The draft ordinance establishes standards for determining which structures, sites, and districts may be of historic value, and also sets the rules for preserving those historic resources.

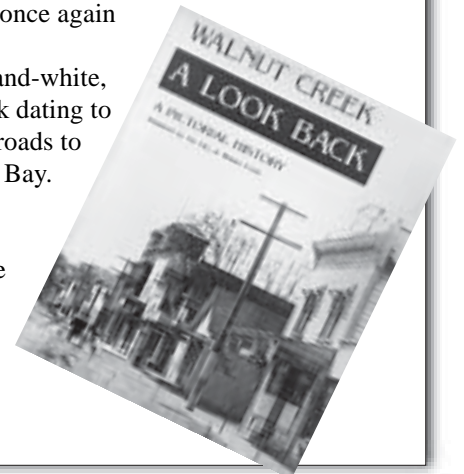
The Commission is expected to make its recommendations to the City Council in late February for final approval of the first historic preservation ordinance for Walnut Creek.

City's pictorial history of Walnut Creek available from Shadelands Museum

City Council Update

Council welcomes new member, selects new mayor for 2007

The City Council on Dec. 5 welcomed as its newest member former Planning Commissioner Cindy Silva, who garnered the second highest number of votes in the Nov. 7 municipal election.

Sue Rainey, who won re-election to her second full term on the Council, was selected by her colleagues to serve her second term as mayor for 2007, succeeding Kathy Hicks. Gwen Regalia was chosen as mayor pro tem for the new year.

Rainey, who served as mayor in 2001-02, has been on the Council since 1997. She served as mayor pro tem in 2006.

Hicks, who did not seek re-election, retired from the Council on Dec. 5 after 17 years of public service, during which she served three terms as mayor and as a member of the Planning Commission and Park, Recreation & Open Space Commission.

In November Hicks received the Elected Official of the Year Award from the California Association of Library Trustees and Commissioners in recognition of her longtime support for a new downtown library.

Rules of the road

I've been a Walnut Creek Police Officer for six years. For the last three years I've been assigned to the Traffic Division as a motorcycle officer. During that time I've discovered that there are an awful lot of rules of the road. The California Vehicle Code is over 680 pages long and we are expected to comply with all of its provisions.



One area that I see drivers consistently struggling with is the proper use of a two-way left-turn lane. 21460.5 (a) of the vehicle code defines a two-way left-turn lane as "a lane near the center of the highway set aside for use by vehicles making left turns in both directions from or into the highway."

The proper use of a two-way left-turn lane consists of observing the following:

- All left-turns or u-turns must be made utilizing the two-way left-turn lane.
- It is illegal to make a left-turn or u-turn from any other lane when a two-way left-turn lane has been designated.
- It is illegal to drive in the two-way left-turn lane for more than 200 feet while preparing for and making a turn or while preparing to merge into the adjacent lanes.

• When turning left onto a roadway with a two-way left-turn lane from a driveway or alley you must first turn into the two-way left-turn lane then merge into the adjacent lanes of traffic when clear.

The most confusing aspect of the two-way left-turn lane is that it can be used by vehicles in opposing directions. For that reason it is important that drivers are alert and use the lane safely. It would be tragic to have a head-on collision in a two-way left-turn lane simply because the drivers forgot the rules of the road.

Get in the swim with Aquatics Gift Cards

Looking for a unique gift for someone? The City is now selling Aquatics Gift Cards that can be used to purchase any number of services offered by the Aquatics Division.

The gift card is easy to use, has no expiration date, and is good for nearly all recreational and community center activities within the City Of Walnut Creek, including: 15 swim punch passes, monthly swim passes, daily lap and weekend recreational swimming fees, swim lessons, stroke clinics, and classes conducted at the community center.

To purchase a gift card, call the City's Aquatics Department at 925-943-5856. The City accepts cash, check or Visa/MasterCard.

When the recipient is ready to use the gift card, he or she will already have an account set up in the City's reservation system with his or her name, phone number, address, and gift card amount imputed. That way it just takes one phone call, or log in to the City's website at walnutcreekrec.org to register for a class or program. Any balances can be applied to the next program.

How you can become a bicycling advisor

She added that the City has selected artist Christian Moeller to create public art for the library.

The new library will be accessible from a new civic plaza at the corner of Broadway and Lincoln Avenue, from the formal entrance on Broadway, from the surface parking lot, and from a Civic Park entrance. The underground parking garage will be built to serve library patrons, community center users, and others visiting downtown.

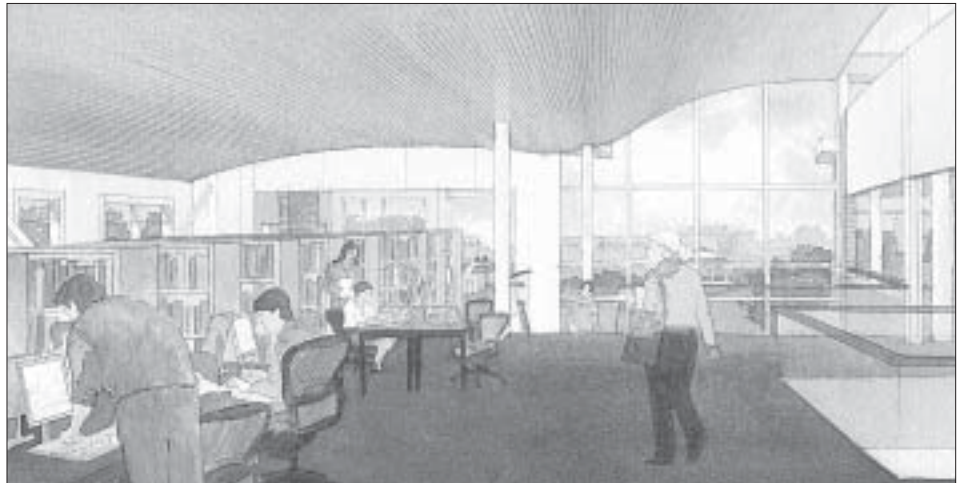
On Jan. 16, the Council will learn more about cost benefit tradeoffs of various elements of “sustainability” — the concept of using design and building materials to conserve energy and reduce operating costs for the life of the building.

City staff at that time will also present an overall funding plan to the Council, said Tinfow.
